- (1) Even considering the nomination of Mr. Lalith Sankhuy without getting him to resign from the various committees was a mistake as he was only an invitee and not an elected member. Before entering any election, the invited member has to resign from all positions in various committees which they hold. This was not adhered to by NC.
- (2) Mr. Lalith Sankhuy has travelled to Hyderabad on Feb 24, 2005, by using CSI funds to participate in a meeting. This clear violation of Code of ethics.
- (3) Mr. Lalith Sankhuy's article was published in CSIC Jan 2005 which was also against Code of ethics set of elections.
