**On this Occasion of Navaratri I wish to make every thing Open, and Calling a Spade a Spade. This Should bring the Evil down by Vijayadasami, I am bringing the truth before you and request to guide how to go further.**

- It all started on 11-01-2017 by Sri. Lalit Sawhney and associates when a Fellowship was awarded to Sri. M L Ravi the Former President of CSI, that the so called intervenors felt that their misdeeds will be exposed and started opposing the Fellowship ( **Anexure-1 Lalit Sawhney on award to ML Ravi**)
- Sri. M L Ravi the elected president of CSI for the year 2005 was replaced with the mollified intentions of the members **who were signatories and also the Intervenorers in the Present case with CSI.** ( **Anexure-2 Notice to ML Ravi by Members with wrong information**)
- The Agreement of sale of Worli Property during the Presidentship of Sri. M D Agarwal on 15-07-2011 with out the approval of CSI AGM and signed by the Employee of CSI who is the Executive secretary for administration impersonating as the Secretary CSI ( **Anexure-3 & 3 A Agreement of Worli Property** ) The Annexure 3 A **Shows only the white amount transferred, but in any Real Property dealing in Mumbai the Black amount is also around 40%. There is neither a mention nor indication of Black amount.**
- A white paper on the Irregularities made during the development of CSI website on 04-06-2015 giving the inside story of CSI web site development between 2010 to 2015 spending Rs.68.5 Lakhs ( **Anexure-4 White Paper on CSI website Development**) which was spearheaded by Sri. S Mahalingam jee & others
- **The Case of the Publication Company where they changed the basic structure of CSI where the Registered Office was changed from Hyderabad to Mumbai and later to Chennai on 23-09-2016, without any approvals while registering the Publications company. Annexure -5**
- The Letter from the then Vice President CSI on 19-01-2017 questioning Sri. Mahalingam Garu regarding the constitution of the Publications Company ( **Anexure-5 Queries on Publications company**) and agreement made with Springer( **Anexure 5 A Agreement with Springer**) which never reached the members of CSI)
- Agreement made with Service and ballot on 03-11-2006 to make e Voting where a clause was incorporated to get the pass codes given to Executive Secretary which was used to Impersonate Election. ( **Anexure 6 Agreement with Survey and Ballot**) . **After the Exit of Exec. Secy the file landed in the arms of Execoms**
- The Mail Chain by Sri. Ramanathan Jee on 10-06-2014 exposing the misdeeds of Sri. Bipin Mehta on mis appropriation of his powers for self advancement. **And blackmail by other Members** ( **Anexure 7 Details by Sri. Ramanathan on Bipin Mehta**)
- A mail by the Execom stopping the mis use of the CSI Fellows group ( **Anexure 8 CSI fellows Group Mis use**) made the group not to spread maligned statements on CSI, they claim to be Think Tank members for whom CSI students contributions are used for them to attend AGM, and for the last 15 years no minutes were recorded and available. Para 7 of the Minutes. ( **Anexure 12: Minutes of the meeting with Justice Sawant**)
- AGM resolution at Coimbatore to allow E Voting only with OTP authentication, To stop Impersonation.
- Keeping the above sequence of events the intervenors felt that their days are numbered in CSI and cannot use CSI for personal benefits any more tried to strangle CSI and Used two members un known as petitioner on 22-06-2018 gave the first legal Notice to CSI and it goes on. ( **Anexure 9- Notice by DMD Associates**)
- You can also go through the mail Trail between the Intervenorers and DMD associates ( **Anexure-10 Mail Trail with DMD associates**) Clearly indicate that they are bent on derailing CSI from 2018.
- With This Background of Mollified intentions intervenors tried to enter directly after the AGM elected us on 31-1-2021 and used the same DMD associates a reputed Legal Organization to disrupt CSI. The usage of the website [www.csiindia.org](http://www.csiindia.org) and the memberships made were informed to Registrar of Societies ( **Anexure-13 Information to ROS**)

- **The most important aspect of CSI is its memberships for Individuals, Institutions and Students. The Institutions need affiliation to societies, and CSI is one prominent old society. The ED and HQ with their attitude are not making any memberships while the intervenors promote other societies even today. We at registered office are continuing memberships not to get CSI killed, and brought transparency in the process which is online. ED & HQ give wrong information to aspirants that our site is illegal for reasons known to them. While we are continuing the membership process. (Annexure-13 Information to ROS)**
- **The Court Order to conduct AGM and elect OB was given on 29-12-2017, to settle the disputes between Appellants & Respondents, but these documents indicate that the intervenors made a plan to destabilize CSI much before, they do not want to CSI to survive and Intervened on the Process of communication of AGM Notice to members. 7495 Validated members 54% of total Count. On 29-12-2020, But Now they want the Court to accept 6598 Validated members 38% of Total Count on 27-07-23, where just 5758 had both mail and Phone authentications .(Annexure 12: Minutes of the meeting with Justice Sawanat)**
- In this Process CSI had spent around Rs.93 Lakhs as legal Expenses between 2018 and 2021 and now the power of attorney representing the appellants is demanding Rs.53 Lakhs as legal Expenses.
- I do not know yet how Sri. Mahalingam Jee Used the Services of TCS for solving the problems of the database of CSI on 25-11-2022 and still waiting for an answer. **Annexure 11 Appeal to TCS**
